JumpRope combines the simplicity of a traditional grade book with the ability to connect priority standards teachers require to assess their students. The student lens of this grade book provides students and parents with a clear look into the standards met or not met on teacher assessments throughout the school year.

Minimum Requirements

Currently, JumpRope is accessed by students and staff through ClassLink. JumpRope uses district-created courses to roster students allowing for a daily updated class roster. JumpRope is a standards-based grade book where teachers add assessments aligned with district and state standards. JumpeRope takes student-assessed scores and turns them into an easy-to-use dashboard displaying achievement based on standards. Teacher PLC groups can then have a common report system to view their student's strengths. JumpRope grade book clarifies learning objectives, makes teaching decisions more intentional, and makes the curriculum more cohesive. It eliminates busy work for students and multiplies the ways for them to demonstrate knowledge. JumpRope's tools empower teachers to do what they do best while collecting meaningful data and providing specific feedback to learners.
