Information and Requirements

1. Regular rates apply for use of facilities during the school year, M - F, 6:00 - 10:00pm. Custodian on site for regular duties only, M - F, 6:00 - 10:00pm. Weekends require 4 hour minimum for custodial, security, and kitchen managers.
2. Additional charges apply, including overtime rate for required staff, for use of facilities beyond hours as listed in #1. Rates identified in Section II.
3. Additional charges apply, including overtime rate for staff, for use of facilities that require extra staff or resources.
4. Depending on nature of event, number of attendees or location, VPS security staff may be required.
5. For youth sports: Statements of Compliance for HB1824 (concussion training) and HB5083 (sudden cardiac arrest awareness training).
6. Proof of insurance required and payment received ten (10) days prior to accessing facility or field.
7. Adult supervision and signed contract required at all times when on site.
8. Adherence to all General Guidelines governing the use of school facilities is required at all times.
