Public School CHOICE School in Improvement

Public School CHOICE is the opportunity for parents to transfer their children that attend a Title I School in Improvement (Step 1-5) building to another school in the district that met Adequate Yearly Progress. The district assists parents with the transportation of their children by paying them mileage reimbursement for travel to and from their home and the chosen school. Schools offering Public School CHOICE must set aside 10% of their building's Title I budget to pay for professional development. The goal is to provide training for school staff on improving the instruction for students in the sub-groups that did not meet AYP, thus improving the chances of helping this group or groups pass the state assessment at the percentage needed for Adequate Yearly Progress.

Public School CHOICE 2015-16

The No Child Left Behind (NCLB) Act requires that 100% of students are proficient on Washington state's 2015 spring state assessments in <u>both</u> reading and mathematics. Vancouver Public Schools did not make Adequate Yearly Progress (AYP) because of this 100% proficiency requirement. Surrounding school districts are not accepting out-of-district boundary exceptions for Public School CHOICE.
